Winner: The Mary Nell Kivikko Excellence in Scholarship Award
John Burkett, Texas Christian University

John Burkett is currently a Ph.D. Candidate at Texas Christian University where he holds several writerly roles: he serves as Instructor of Composition, Editorial Assistant of *Composition Studies*, Writing Tutor in the William L. Adams Center for Writing, and

Writing Coach in the Neeley School of Business. For his dissertation.

John is writing a commentary on Aristotle's *Art of Rhetoric*. John joined TCU in 2005 as the Lillian B. Radford Fellow in Rhetoric and Composition. His studies and research have focused on applying classical rhetoric to modern writing. Along with Richard Leo Enos and other editors, he is helping to produce the book, *The Rhetoric of St. Augustine of Hippo:* De Doctrina Christiana *and the Search for a Distinctly Christian Rhetoric* (Baylor UP, Fall 2008). Dr. Dave Kuhne of TCU edited *descant: fifty years*, an anthology of the best work appearing in the first fifty years of *descant*. TCU Press will publish the book in June. Kuhne is currently researching another book for TCU Press: *Big Country Texas*. The project will involve an informal survey of the geography, history, and culture of the Texas big country, an area that stretches roughly from Brownwood to San Angelo to Abilene. 

At CCCC, **Shannon Carter** was elected to join Hannah Ashley (West Chester University) as Co-Director of the Conference on Basic Writing, the national organization for basic writing studies.

Dr. Shannon Carter of Texas A&M Commerce joined the editorial board of the national, peer-reviewed journal *Young Scholars in Writing: Undergraduate Research in Writing and Rhetoric* and began, with Doug Downs of Utah Valley State University, a new feature publishing outstanding scholarship in writing, rhetoric, and literacy studies produced by first-year writers. The first issue including this new feature was published in January 2008 (YSW, volume 5) and included an essay written by A&M-Commerce student Eric Pleasant in his English 102 course spring 2007 ("Literacy Sponsors and Learning: An Ethnography of Punk Literacy in 1980s Waco").

Dr. Kathleen Mollick of Tarleton State University presented a paper entitled "Riches of Embarrassment: The Faltering Reelection Ethos of George H.W. Bush" at the Federation Rhetoric Symposium at Texas Woman's University in February. The paper focused on Bush's 1992 State of the Union Address, in which he hoped to forcefully argue to the American public why he was the strongest candidate in the upcoming election. Analyzing the speech's use of candid speech (parrhesia) to build the president's ethos, the paper noted areas in which Bush's reelection discourse fell short in being persuasive to his audience.

She will also be presenting another paper on the reelection discourse of George H.W. Bush at the Rhetoric Society of America conference in Seattle this May.

Ryan Farrar, a first-year graduate assistant at Tarleton, recently presented at the Pop Culture Conference/American Culture Conference in San Francisco in March. The presentation, "Digesting the Sap: Applying I.A. Richards's Semantic Triangle to Darren Aronofsky's *The Fountain*," focused on how, in the Post-Modern era, film has developed as a useful and visual tool in capturing Western Civilization's attitudes towards the surrounding reality as denoted by time. With film allowing the human race to capture spots of time and perpetuate the motives that call the future generations to action, audiences attend theaters in an attempt to dissociate themselves with the inevitable destination death in exchange for stories that transcend mortality. Recently, Darren Aronofsky's film, *The Fountain*, attempted to persuade film audiences of time's absolute and relativistic nature by advocating eternal hope through inescapable death. In order to structure the argument, the film employs ideas of religious mythos, particularly Christian and Mayan, Romantic dualism, biological symbolism, Orwell's concept of "the last man," and futurism as memes for understanding Man as a monadic force in the universe. The focus of his analysis explored the rhetorical purpose each device serves in communicating the director's purpose to the audience.
